About Tennessee's Community Health Centers

Tennessee's Community Health Centers (CHCs) provide cost-effective, community-based, quality primary care services to all people regardless of their ability to pay. Community Health Centers not only help to keep the state's people healthy, they help keep the state's economy healthy, too.

A Commitment to Quality

RECOGNIZED LEADERS IN QUALITY

In 2016, 27 Tennessee CHCs received quality improvement awards from the U.S. Department of Health and Human Services for performance in several key areas:

- High Value Health Centers: Delivered better, smarter, healthier care by improving cost efficient care delivery compared to the national average while also increasing quality of care and improving access to comprehensive services.
- Clinical Quality Improvers: Demonstrated notable improvement in one or more clinical quality measures (CQM) between 2014 and 2015.
- Health Center Quality Leaders: Achieved the best overall clinical performance among all health centers.
- Electronic Health Record (EHR) Reporters: Employed EHRs to report on all CQM data for all of the health center's patients.
- PCMH Recognition: Went to health centers that achieved PCMH recognition for their service delivery

INTEGRATED CARE MODELS:

MEDICAL, BEHAVIORAL HEALTH AND DENTAL

Community Health Centers are expanding to provide dental services and integrated behavioral health services to address the dire need for these services in medically underserved areas. They are also using cutting edge telehealth equipment to improve access to specialty care for patients in underserved and/or rural areas of the state.

PATIENT-CENTERED MEDICAL HOMES

Sixteen Tennessee organizations (with a combined total of 68 sites) are recognized (NCQA) or certified (Joint Commission) as Patient-Centered Medical Homes.

SMALL BUSINESSES SUPPORTING THEIR COMMUNITIES Community Health Centers employ more than 2,350 fulltime employees such as physicians, dentists, clinicians, administrators and other staff. Health centers are economic engines in their communities, saving the residents money and preventing more expensive care in the future.

369,445

Member health centers served 369,445 patients in 2015. Approximately 25% of patients seen are 18 years old or younger.

Regardless of Insurance Status




Of the 30 federally funded Community Health Centers and Look-Alikes, the average patient population mix is approximately 35% uninsured and approximately 34% TennCare, with Medicare and privately insured patients comprising the remainder.
